1. DECLARATION

Declares that he or she is in good health, does not suffer from psychophysical pathologies of any type, temporary or permanent ones, which could cause danger for him/herself or others during the execution of the Adventure Park Course called "PARCALLARIO";

He/She also declares to:

1. have obtained by PARCALLARIO's technical staff all the necessary equipment, in a good state and suitably certified, for the execution of said Adventure Park Course;
2. have examined the Adventure Park Course and to be aware of the difficulties that might meet and the scrupulous attention which shall have to pay to the instructions been given;
3. follow instructions conscientiously;
4. have obtained, has understood and is able to put into practice the instructions been given during the theoretical and practical briefing received for the safe utilization of mobile and fixed equipment of the Adventure Park Course, also illustrated on the signs by each platform;
5. have understood and was put into practice and, therefore, is able to open and close correctly all the karabiners been supplied with;
6. have understood, amongst all other instructions, the importance and the compulsoriness of verifying that the harness is firmly tight to the body (bust and thighs) and that at least one of the snap-hooks been provided must be always and constantly inserted in the safety cable throughout the duration of the Adventure Park Course;
7. authorize this firm to carry out photo shootings and/or films with the exclusive use of promoting the activity and updating the controls relating to the safety of the equipment.

He/she is aware of the fact that, once the PARCALLARIO route is over, the Manager will not be held responsible for any accidents or anomalies incurred AFTER giving back the safety equipment (sling and helmet). Communication of such accidents or anomalies must be given BEFORE handing back said equipment.

He/She also declares of being of age and of **having read the Regulations** displayed on the notice at the Park entrance, who undertakes to observe every part of it.

REGULATION

IMPORTANT

Tackling the various passages of an Adventure Park at several meters above the ground can involve implicit risks which can be minimized if the rules indicated during the briefing and underlined by these regulations are respected.

EACH USER IS GUARANTEE AND RESPONSIBLE FOR HIS OWN SAFETY.

Taking into account the specificity of this activity, follow the points listed below:

1. Access to the Paths is allowed only to those who:

- are provided with a ticket certifying the purchase corresponding to the chosen package;
- have read and signed in full acceptance the Regulations and Safety Techniques of "PARCALLARIO" for themselves or as responsible escorts of minors;
- have filed an identification document for the withdrawal of PPE (Personal Protective Equipment) - it is sufficient client 1 document per family or group which will be returned upon delivery of the PPE.

2. The cost of the ticket includes:

- the rental of PPE for the duration of the chosen routes, which can go from 1 hour to 3 hours or daily
- the teaching of progression and safety techniques and the verification of the level of learning within a short course called "Briefing";
- control and supervision by the personnel in charge and, if necessary, their intervention in case of emergency.

3. Before getting on the Acrobatic Courses it is MANDATORY:

- participate in the instructional briefing on the use of PPE and on safe progression techniques for those participating for the first time in the Parcallario Acrobatic Paths activities;
- practice progression techniques within the Practice Areas (both children and adults).

4. Along the Acrobatic Routes:

- users must respect the rules learned in the briefing and indicated by signs, it is MANDATORY to stay always anchored to the safety cable called CONTINUOUS LIFE LINE (never be on the routes with the carabiner in hand) and hook up the pulley only where indicated with a yellow sign for ziplines;
- always check that the zipline arrival platforms are free before jumping from the platform;
- users must wear suitable and comfortable sports clothing, suitable shoes (sneakers or trekking shoes) and have their hair tied back if it is long, remove any accessories that could get entangled (rings, scarves, earrings, pendants, necklaces.....)
- only one person at a time can access each element of the route, including the access stairway;
- a maximum of 3 people can stay on the platforms at the same time;
- it is FORBIDDEN to voluntarily swing and shake the course elements and to throw any object on the ground;
- on the routes it is strictly forbidden to smoke and to use the mobile phone or to engage the hands in movements that are not guaranteed a safe progression for themselves and for other users;
- the use of personal PPE (harnesses, helmets, carabiners or pulleys) is FORBIDDEN;
- each user is aware that he will progress along the Paths INDEPENDENTLY AND UNDER THEIR OWN RESPONSIBILITY- accompanying adults are responsible for minors;

5. LIMITATIONS on the use of Acrobatic Courses:

- the management reserves the right to prohibit access to the routes to people it deems unsuitable.
- anyone who behaves dangerously, putting himself at risk and causing problems for others, will be removed from the park.
- the itineraries cannot be accessed under the effects of alcohol, drugs or medicines that limit the psychophysical capacities;
- it is use is not recommended for people with limited motor skills and pregnant women;
- in the event of atmospheric perturbations, the instructors will be able to interrupt the activities on the routes and a certificate will be issued voucher for a subsequent entry; NO REFUNDS.
- Access to the Paths is strictly prohibited during the closure of the Facility and/or in the absence of control personnel.

The management assumes no responsibility in the event of an accident caused by your negligence or non-compliance with the regulations and by non-compliance with the safety standards.
